#### **POSITION SUMMARY**

The Director of Alliance Development will drive strategic and operational excellence in the Alliance for Regenerative Medicine's (ARM) partnered activities, representing the organization in various forums, and supporting direct partner interactions in ARM's highest priority alliance/partnered activities. This role will also participate in the coalition development activities associated with academic and industry partnerships. Working in an open and mutually beneficial way to enable the development and delivery of engineered cell therapies and genetic medicines that are durable, potentially curative in nature for patients many living with severe genetic and rare diseases. The position reports to the Vice President of U.S. Government Affairs.

#### JOB DUTIES

For the purposes of this job description, "NGOs" include Minority Health Groups, General Medical Professional Societies, Professional Societies, Patient Advocacy Organizations, Social Justice Organizations, Industry Associations, Health Care Non-Profits/Foundations, Technology/Innovation centers and Think Tanks The successful candidate will have a proven ability to build trust and establish shared patient access goals between NGOs and ARM using the patient as the ultimate compass and ensure the policies advance benefit the patients.

- This role is an integral part of the ARM team in the development of strategic priorities, U.S. Federal issues consistent with ARM's priorities, objectives and mission.
- Develop a longer-term approach to identifying and engaging select NGOs to serve as members of ARM, including patient advocacy organizations, foundations, medical societies, and academic & research institutions.
- Facilitate the engagement of NGOs in Congressional briefings, roundtables and hearings that enable progress against policy goals in regulator and payer domains.
- Partner with senior ARM leaders to ensure appropriate engagement with key NGOs, including with their senior leaders, committees, boards, working groups, and events; ensure full ARM community is well-represented at major events/conferences, including Meeting on the Mesa, J.P. Morgan, and FDA Scientific Exchanges, as appropriate.
- Refine the ARM Alliance Development Engagement Plan, including identifying opportunities to engage NGOs with which ARM has not traditionally collaborated, and to support, expand or refocus existing participation efforts.
- Design, track, manage, and report performance metrics associated with NGO engagement.
- Lead and generate communication to/from key third party organizations on appropriate key ARM regulatory and legislative issues, as deemed necessary.
- Share best practices with ARM's EU team on strategic engagement with NGOs, as well as assist in the recruitment of International NGOs into related coalitions.

- Bachelor's degree required, preferably in Marketing, Communications, Political Science, Life Sciences, or related field
- Requires a minimum of 7 years related experience including a combination of healthcare and/or government advocacy work with an excellent understanding of points of influence within NGOs
- Experience working with public policy, and elected officials/staff
